

# First Baptist Church of Mt. Healthy Rules & Regulations for Paintball Participants 2011 Season

**It is our goal that all guests feel welcome, safe and respected. These rules are for your protection. We ask that all players read and follow these rules and exercise mutual courtesy to all other players and volunteers. After you have read the rules, please sign the bottom to signify your understanding and agreement.**

- 1) Participants must be 12 years or older.
- 2) Players must test their markers before every game to ensure the velocity of the projectile is not excessive. The velocity limit at the Paintball Junkeez field is **280fps**. Damaged or defective safety gear will not be allowed.
- 3) Markers set for fully automatic, ramping or burst modes are not permitted.
- 4) No profanity is permitted.
- 5) All players and observers will wear facemasks at all times when in play or near an active game. The viewing area of the facemask must be kept clean and unobstructed.
- 6) A barrel sock will be placed on the end of the barrel at all times that you are not a player in an active game. Barrel plugs are not permitted.
- 7) When you are hit, you must immediately raise your hand and verbally indicate that you have been hit and leave the playing field with your hand still raised. A "hit" is a quarter-sized break or splatter. Only referees can reverse hit calls; if you're unsure if you've been hit, call for a paint check before calling yourself out.
- 8) Unless otherwise instructed by specific scenario rules established at the start of each game, players who are hit may not communicate with their teammates while exiting the field.
- 9) If you need to leave the playing field for any reason, you will raise your hand as if you were hit and leave the playing field. Refer to rule #11 for re-entry explanation.
- 10) Players with a raised hand may not be shot and are given free passage from the playing field.
- 11) No player may leave the field and then return to an active game. If you leave a game, you must wait for the next game to rejoin. Exception: if the ground rules for a scenario allow for re-spawning, players must follow the guidelines outlined for that specific scenario in order to re-enter the game.
- 12) You will not shoot another player within 10 feet of the end of your barrel. To eliminate a player in close proximity, call "BUNKER." Assaulting player must obtain line of sight before calling "bunker" and call "bunker" for each player being eliminated.
- 13) If you are injured during play, raise your hand to avoid being shot and call out "INJURED PLAYER." The game will be terminated and all players will place barrel socks on their guns.
- 14) If you hear a player call "INJURED PLAYER," you will also call out "INJURED PLAYER" to let others know there is an injury and that the game is being terminated.
- 15) Referees have the final word. Any player arguing with a referee will be asked to leave the game. No player may shoot at a referee.
- 16) No drugs or alcohol will be permitted and no player will be allowed to participate if they are under the influence of drugs or alcohol.
- 17) Use of the Paintball Junkeez field is limited to the times specified by the Paintball Junkeez Crew. Use of the field without the presence of a member of the Paintball Junkeez Crew is not permitted.

**Any violation of these rules may result in one or more of these actions:**

- 1) For a minor offense, a referee or representative of the First Baptist Church of Mt. Healthy will give the player a verbal warning.
- 2) For major or repeated offenses the player will be asked to leave the premises for the remainder of the game day.
- 3) Illegal activities will result in the filing of a police report against the offender(s).

HEALTHY** in the county of HAMILTON and state of OHIO, beginning on the day of signing the undersigned: hereby voluntarily and absolutely releases, discharges, waives and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage or wrongful death occurring as a result of observing or using facilities or equipment of the First Baptist Church of Mt. Healthy, or engaging in or receiving instruction in any activities **SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY** or in activities thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue. The undersigned him/herself, his/her heirs, executors, administrators or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against the First Baptist Church of Mt. Healthy or its officers, agents, servants or employees, the undersigned will indemnify and hold harmless the First Baptist Church of Mt. Healthy or its officers, agents, servants or employees from any and all claims or causes of action or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will the undersigned present any claim against the First Baptist Church of Mt. Healthy and said persons for personal injuries, property damage, wrongful death or otherwise caused by any act of negligence by the First Baptist Church of Mt. Healthy and said persons.

The undersigned represents that he/she has read this release, has requested and has been provided with, or has requested and declined advisement of the potential dangers/risks of engaging in the observation, activities or instruction offered, assumes all risks associated with such dangers and risks, and is fully aware of and understand the terms and the legal consequences of the signing of this release. The undersigned intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the release is held invalid, it is agreed that the balance shall, notwithstanding, continue in legal force and effect.
